**Directions to Cameron**

Coming from 1-10, take the Cameron/Creole Exit or Hwy 397. Go south, and cross over Highway 90. Stay on Hwy 397 until you reach the roundabout. At the roundabout, take the 3<sup>rd</sup> exit, heading east onto Highway 14. Stay on Hwy. 14 until you get to a small community called "Holmwood". At Holmwood, continue straight onto Hwy 27. You will enter Cameron Parish and keep heading south. You will see the Cameron Prairie Refuge on the right on Hwy 27. Keep going straight. Cross the Gulf Intracoastal Waterway at the Gibbstown Bridge, keep going straight. You will get to the red light in Creole. Turn right and go approximately 10 miles to a yield sign and turn right. From the yield sign to the Courthouse is approximately 4 miles west. The Courthouse will be on the right.
